



EXHIBITOR GUIDELINES AND REGULATIONS  
THREE RIVERS CONSERVATION CLUB (3RCC) OUTDOOR EXPO 2010

1. The date of the event is Saturday May 22, 2010 from 11:00am until 7:00pm.
2. Entry fee for each exhibitor will be \$30 plus a donation of an item(s) with a retail value of \$30. The item(s) should be related to the outdoors in some manner. Examples include but are not limited to knives, shooting accessories, archery accessories, other hunting or fishing equipment, your business's hat and/or shirt with your logo, a gift certificate to your business.
3. This/these item(s) will be placed on your display table and a "bucket" or can will be placed beside it. Expo attendees will have the opportunity to purchase raffle tickets from 3RCC that can be placed in the bucket that corresponds to the item(s) that they wish to have a chance(s) to win at the end of the day.
4. Exhibitors may display, demonstrate, or sell any outdoor related items that they wish.
5. Any and all raffles and ticket sales as well as concession sales may only be conducted by 3RCC.
6. Sales of any items or tickets other than the exhibitors display items must first be approved by 3RCC.
7. Each exhibitor will be allotted an approximately 10 ft. area for their display. One table and two chairs will be supplied for each exhibitor.
8. Any firearm sales subject to a federal firearms background check will be that exhibitor's responsibility. A land line phone will be available for FFL holders to use for the background check.
9. Firing of live ammunition is prohibited during the event unless otherwise authorized by 3RCC.
10. Each business is responsible for their display in terms of safety and security.
